

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution entitled, "Appointment to United Tribes Technical College"
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5(1) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to adopt resolutions regulating the procedure of the Tribal Business Council, other Tribal Government entities and Tribal officials; and
- WHEREAS, The Tribal Business Council has deemed it in the best interests of the Three Affiliated Tribes of the Mandan, Hidatsa and Arikara Nation on the Fort Berthold Reservation to participate in those local, state, regional and national boards, commissions and other such organizations that oversee services that are now or may be beneficial to the tribal membership; and
- WHEREAS, The Tribal Business Council desires to continue participation in the United Tribes Technical College; and so
- NOW, THEREFORE, BE IT RESOLVED That the Tribal Business Council hereby submits Chairman Marcus D. Wells, Jr. and Vice Chairman Nathan Hale to serve in the capacity of representatives of the Three Affiliated Tribes Tribal Business Council; and
- BE IT FURTHER RESOLVED That Chairman Wells and Vice Chairman Hale are vested with all authority, duty, and responsibility inured in the representative capacity during the tenure of their appointment to the United Tribes Technical College; and
- BE IT FURTHER AND FINALLY RESOLVED That the authority of this resolution officially rescinds all prior resolutions that ordain previous or existing appointments to the United Tribes Technical College which are subject to appointment by the Tribal Business Council of the Three Affiliated Tribes, and categorically supplants any existing resolutions that may have authorized an appointment by prior Tribal Business Council action.
