A Resolution entitled, **Donovan Evans Abbey 301U-07809**

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Buisness Council to engage in activities on behalf of and in the interest of the welfare and benefit of the enrolled members thereof; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Buisness Council to revise the membership rolls and to govern future membership rolls, and
- WHEREAS, **Donovan Evans Abbey** requested relinquishment of his/her membership from the Three Affiliated Tribes, Membership has been requested with the **Coushatta Tribe**, and
- WHEREAS, A copy has been received of application confirmation from the *Coushatta Tribe*.
- NOW THEREFORE BE IT RESOLVED, that *Donovan Evans Abbey* is hereby relinquished from the official membership roll of the Three Affiliated Tribes.
- BE IT FURTHER RESOLVED, that the *Coushatta Tribe*, is to be advised with a copy of this resolution.
