

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Authorization for Three Affiliated Tribe Tribal Housing Division to apply for USDA Rural Housing Section 525 – Technical and Supervisory Assistance Grant"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having duly adopted a Constitution and By-laws pursuant to said Act on May 15th, 1936; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Three Affiliated Tribes' Constitution authorizes and empowers the Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and
- WHEREAS, Article VI, Section 5 (1) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, Article VI, Section 5 (d) of the Constitution of the Three Affiliated Tribe Provides that the Tribal Business Council has the power to negotiate with Federal, State and local governments on behalf of the Tribe and to advise and consult with representatives of the Interior Department on all activities that may affect the Fort Berthold Reservation; and
- WHEREAS, To address the unmet housing needs for the members of the Three Affiliated Tribes, the Tribal Business Council has established the Tribal Housing Division whose primary purpose is to provide homeownership opportunities for tribal members through the various tribal, federal and state housing development resources available to the Tribes and its members; and
- WHEREAS, The United States Department of Agriculture (USDA) Rural Housing has grant funds available through the Section 525 – Technical and Supervisory Assistance Program which can be used to provide technical and supervisory assistance for



low income individuals in rural areas to pursue successful homeownership opportunities; and

- WHEREAS, Grants under the RH Section 525 Program are made available to public bodies, including Indian Tribes; and
- WHEREAS, The Tribal Housing Division has requested authority to apply for the USDA Rural Housing Section 525 Grant in the amount of One Hundred Thousand Dollars (\$100,000.00) to assist low income families with technical and supervisory assistance in the form of counseling, homebuyer education, credit management and loan packaging for the attainment of successful home purchases/construction/refinances on the Fort Berthold Reservation.
- WHEREAS, The Tribal Business Council finds that it is in the best interests of the Tribes to authorize the Tribal Housing Division to apply for said grant funds from the USDA Rural Housing.

NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby authorizes the Director of the Housing Division to apply for a Rural Housing Section 525 Grant to be used for the purposes authorized by said grant application; and

BE IT FURTHER RESOLVED, that the Tribal Business Council hereby authorizes Tribal Chairman Tex G. Hall and Tribal Secretary Nathan Hale to sign all applications, agreements, assurances and other documents necessary to apply for said grant.

CERTIFICATION
