

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This nation having accepted the Indian Reorganization Act of June 18, 1934, and the Authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and the enrolled members thereof; and
- WHEREAS, Title I, Chapter 1, Section 4.2 of the Fort Berthold Tribal Code specifically authorizes and directs the tribal Business Council to appoint licensed attorneys to each serve in the capacity of Associate Judges on a calendar year; and
- WHEREAS, It is the considered judgment of the Tribal Business Council that the Judiciary of the Three Affiliate Tribes must maintain exceptionally qualified judicial officers to up hold the laws and customs of the Tribes; and
- WHEREAS, The Tribal Business Council has selected BJ Jones, Peter Furuseth and Terry Pechota, Robert Holte to serve as Associate Judges in the Fort Berthold District Court during calendar year 2007; and
- NOW, THEREFORE, BE IT RESOLVED, The Tribal Business Council also hereby re-appoints Michael Swallow to serve as an Associate Judge to fulfill duties as assigned by the Chief Judge, in her absence or by her assignment. The appointed Judge shall also preside over special courts as designated by the Chief Judge, including but not limited to child support, probation hearings and juvenile adjudications.
- BE IT FURTHER RESOLVED, That the rate of compensation for each appointee shall be Five Hundred Dollars (\$500.00) per day per court session, in addition to reimbursement of documented travel expenses and (\$50.00) fifty dollars per hour for approved work related to a particular case.

BE IT FURTHER RESOLVED, That the Tribal Business Council hereby directs the Fort Berthold District Court to prepare the appropriate consultant agreement for the respective appointee identified herein above, and to specify that the rate of compensation shall be Five Hundred Dollars (\$500.00) per day court session, in addition to payment for pre approved case related work and reimbursement of documented travel expenses.
