

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution Entitled: "Approval of Change of Client Applicant for the FY 2006 Housing Improvement Program Allocation for Category C-Replacement Housing Assistance"
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to negotiate with the federal government on behalf of the Tribes; and
- WHEREAS, The Tribal Business Council authorized and manages the Bureau of Indian Affairs Housing Improvement Program pursuant to 25 CFR Part 256 and in accordance with a contract under P.L. 93-638, the Indian Self-Determination and Education Assistance Act; and
- WHEREAS, In 2006 several tribal members were approved for Category C-Replacement Housing Assistance, including John Beston, however Mr. Beston has now formally declined to accept the Category C Assistance he was approved as eligible for; and
- WHEREAS, Sadie Mann has been determined eligible and approved for Category C-Replacement Housing Assistance for 2007 and the Tribe's Housing Improvement Program has requested approval to award Ms. Mann the funds and assistance that



have been declined by Mr. John Beston for 2006;

**NOW, THEREFORE BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes hereby approves Sadie Mann for the Category C-Replacement Housing Assistance for FY-06 that was declined by John Beston.
