**RESOLUTION OF THE GOVERNING BODY
OF THE THREE AFFILIATED TRIBES
OF THE FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled: *“Tribal Business Council Approval and Certification for the FY 2007 Grant Application for the ICDBG Grant Program for the Four Bears Segment Multi-purpose Building.”*

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and

WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Pursuant to Article VI, Section 5 (l) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and

WHEREAS, The Tribal Business Council has authority to engage in activities on behalf of and for the welfare and benefit of the Tribes and of the Tribes of the enrolled members thereof; and

WHEREAS, Pursuant to Article VI, Section 5 (d) of said Constitution, the Tribal Business Council is authorized to negotiate with the federal government and advise the federal government with regards to all appropriations estimates or federal projects for the benefit of the Three Affiliated Tribes, and

WHEREAS, the Tribe has authority to submit applications to the U.S. Department of Housing and Urban Development (HUD) for the Indian Community Development Block Grant (ICDBG) program and the Tribal Business Council has decided that the first priority for the ICDBG Grant Application for FY 2007 shall be to build a new Multi-purpose Building for the Northwest/Four Bears Segment with a total grant request of \$900,000 + 25% tribal cash match of \$300,000 for a total project cost of \$1.2 million; and

WHEREAS, Pursuant to Resolution No. 05-97-NH the Tribe has adopted, acknowledged, and accepted the Maintenance and Operation Plan required by HUD for all proposed community facilities and commits to providing annually the necessary financial support in the amount of \$30,000.00 for these responsibilities; and

WHEREAS, all community facilities owned in whole or in part by the Three Affiliated Tribes are covered under the Tribes' comprehensive insurance policy; and

NOW, THEREFORE BE IT RESOLVED, the Tribal Business Council of the Three Affiliated Tribes hereby authorizes the FY 2007 ICDBG Grant application in the amount of \$900,000 for the purpose of constructing a multi-purpose building for the North West/Four Bears Segment Community; and

FURTHER, BE IT RESOLVED, that the Four Bears Segment of the Three Affiliated Tribes shall allocate \$10,000.00 annually for a maintenance reserve fund for the new facility; and

FURTHER, BE IT RESOLVED, that the Tribal Business Council hereby certifies that the requirements of 24 CFR 953.6049 (a) and (c) have been complied with in the development of the FY 2007 ICDBG grant application to ensure adequate citizen participation and input and further certifies that at least 85% of the beneficiaries of the purposed project are at or below low and moderate incomes; and

FURTHER, IT BE RESOLVED, the Tribal Business Council hereby certifies that the demographic data submitted with the FY 2007 ICDBG grant application has been systematically collected, is systematically reliable and feasible and is independently verifiable; and

FURTHER, IT BE RESOLVED, the Tribal Business Council hereby certifies that Four Bear's Community is the priority for FY 2007 ICDBG and that it will provide a cash match of 25% of the total project cost in the amount of \$300,000 in compliance with the ICDBG grant requirements for the FY 2007 application (Total grant request is \$900,000.00 + 25% cash match of \$300,000 = 1,200,000.00); and

FURTHER, IT BE RESOLVED, that the Tribal Business Council hereby authorizes Tribal Chairman Marcus D. Wells, Jr. and Tribal Secretary V. Judy Brugh to sign and certify all agreements, applications, and other documents necessary for said grant application; and

FINALLY BE IT RESOLVED, the Three Affiliated Tribes hereby adopts and adheres to all codes of conduct, financial management, procurement and internal control policies and procedures in compliance with 24 CFR Part 84 and 85; 24 CFR Part 1003 in the administration of all ICDBG projects.


