A Resolution Entitled: *“Approval of Clients Applicant for the FY 2007 Housing Improvement Program Allocation for Category C-Replacement and B-Renovation Housing Assistance”*

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and

WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to negotiate with the federal government on behalf of the Tribes; and

WHEREAS, The Tribal Business Council authorized and manages the Bureau of Indian Affairs Housing Improvement Program pursuant to 25 CFR Part 256 and in accordance with a contract under P.L. 93-638, the Indian Self-Determination and Education Assistance Act; and

WHEREAS, In 2007 several tribal members approved for Category C-Replacement Housing Assistance, are as follows; Pliga Bordeaux, Etheline Stevenson, Edward Danks, Norman Baker, Russell Bird, Lillie Smith and Valentine Finley, Sr.; and

WHEREAS, Irene Meyers has been determined eligible and approved for Category B-Renovation Housing Assistance for 2007, and the Tribe’s Housing Improvement Program has requested approval to award the funds and assistance that will be allocated.

NOW, THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby approves Assistance for FY-07.
