

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Approval of Leasing Approximately 5000 Acres to Marathon Oil Company for Oil and Gas Development on the Fort Berthold Reservation."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Fort Berthold Indian Reservation of the Three Affiliated Tribes (the "Tribe") comprises approximately 1,000,000 acres and has within it potentially significant oil and gas resources as the Reservation lies within the generally accepted geologic formation known as the Williston Basin, a proven oil field since the early 1950's; and
- WHEREAS, The Three Affiliated Tribes issues leases pursuant to the Act of May 11, 1938 (25 U.S.C. Sections 396a et.seq.) and regulations thereto, including 25 CFR Part 211 (2006); and
- WHEREAS, The Three Affiliated Tribes is actively seeking to develop its resources for the economic benefit of the Tribe and all of its members, in order to provide revenue to the Tribe and employment for tribal members; and
- WHEREAS, The Tribal Business Council has received a proposal from Marathon Oil Company ("Marathon"), 3025 Highway 22 North, Dickenson, North Dakota 58601, to lease Tribal minerals within the Fort Berthold Indian Reservation; and
- WHEREAS, Marathon seeks to lease all Tribal lands located within the following sections for oil and gas development:
 - 1. T152N-R93W Sections 9, 10, 11, 14, 15, 16, 20, 21, 22, 27, 28, and 33;
 - 2. T147N-R95W Sections 1, 2 and 12;
 - 3. T148N-R95W Sections 34 and 35;
 - 4. T147N-R94W Section 6; and
 - 5. T147N-R93W Sections 20, 27, 28, 29, 30, 34, 35, and 36;

Located in McKenzie, Mountrail and Dunn Counties of North Dakota; and

- **WHEREAS**, The total number of acres Marathon desires to lease is estimated at approximately acres; and
- WHEREAS, Marathon has offered a \$110 per acre bonus, 18% royalty and 2.00 per acre rental for a five year lease(s) for said lands; and
- WHEREAS, The Tribal Business Council finds this offer favorable and further finds it to be in the best interest of the Three Affiliated Tribes to accept this offer; and
- **WHEREAS**, The Tribal Business Council desires to lease said lands to Marathon under the terms described.

NOW THEREFORE BE IT RESOLVED, The Tribal Business Council hereby accepts Marathon's offer and authorizes the Tribal Chairman to execute an oil and gas lease or leases as necessary on behalf of the Tribe for the lands and under the terms described above.

NOW THEREFORE BE IT FURTHER RESOLVED, in accordance with Statute, 25CFR Section 211.29 and the Constitution and Bylaws of the Three Affiliated Tribes of the Fort Berthold Reservation, the Tribal Business Council hereby expressly supersedes and waives the leasing procedure set forth in said statute and regulations, including among others, the advertisement and bidding procedures, and directs the Secretary, acting through the Bureau of Indian Affairs, to approve the leases issued pursuant to this Resolution.

NOW THEREFORE BE IT FINALLY RESOLVED, the Tribal Business Council hereby requests that the Bureau of Indian Affairs expedite the approval of said lease.
