RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "High Plains Cultural Center Point of Contact"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and
- WHEREAS, pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, pursuant to Article VI, Section 5 (l) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, the Dunn County Fair Association and the High Plains Cultural Center Building Committee have launched a campaign to construct a regional multiuse center in Killdeer, North Dakota for cultural, educational, training, and social opportunities; and
- WHEREAS, the proposed facility is expected to house a myriad of cultural and educational activities including "classes, training, competitions, conferences, dances, senior citizen activities, rodeos, concerts, sales, Native American gatherings, vehicle shows, talent shows, 4-H and Scouting events, and ethnic festivals celebrating our Native American, ranchers, homesteaders, and European immigrant roots."; and
- WHEREAS, planners of the proposed facility are requesting involvement and on-going communication with the Mandan, Hidatsa, and Arikara Nation to ensure that the inclusion and interpretation of Mandan, Hidatsa, and Arikara history and culture is addressed in a culturally appropriate manner in all phases of the High Plains Cultural Center development; and
- WHEREAS, Amy Mossett is currently employed with the Twin Buttes Tribal Office, is a resident of Dunn County, and has expressed interest in advising the planners in the development of the proposed High Plains Cultural Center; and

NOW, THEREFORE BE IT RESOLVED, that Amy Mossett, an enrolled member of the Mandan, Hidatsa, and Arikara Nation, be designated as the Tribes' official point of contact for the High Plains Cultural Center development project in Dunn County; and

FURTHER, BE IT RESOLVED that Amy Mossett is authorized to attend all planning meetings and activities for the purpose of maintaining appropriate communications between the planners of the proposed facility and the Tribal Business Council via the Twin Buttes Tribal Council Representative.
