



**RESOLUTION OF THE GOVERNING BODY
OF THE THREE AFFILIATED TRIBES
OF THE FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled: “2008 Docket Funds Draw in the Amount of \$438,541.54.”

WHEREAS, This Nation has accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, Article III, Section 1 of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Article VI, Section 5(a) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council shall have the power to manage all economic affairs of the Three Affiliated Tribes; and

WHEREAS, Article VI, Section 5 (c) of the Constitution provides that the Tribal Business Council has the power to administer all funds within the exclusive control of the Tribes and to make expenditures from available tribal funds for public purposes of the Tribes; and

WHEREAS, The Three Affiliated Tribes Tribal Business Council has reviewed the status of the FY-2008 Docket Funds income earnings per the 9-30-07 Detail of Trust Funds Summary Report; and

WHEREAS, That the Three Affiliated Tribes Tribal Business Council hereby approves the withdrawal of earnings for the Docket Funds for FY-2008 with the attached 2008 Docket Funds Budget, and

NOW THERE FOR IT BE RESOLVED, the Tribal Chairman and Tribal Treasurer can disburse funds as authorized by the Plan; and further, that this draw will be for earnings posted per the 09-30-07 Detail of Trust Funds Summary Report.

BE IT FURTHER RESOLVED, There are currently interest funds in the amount of \$438,541.54 available from the Three Affiliated Tribes Docket Funds and the Tribal Business Council desires to request this amount from the Office of Special Trustee

BE IT FINALLY RESOLVED THAT, the Tribal Business Council of the Three Affiliated Tribes pursuant to its constitutional authority and pursuant to 25 CFR 115.815 hereby requests and directs the Office of Special Trustee to make available for draw by the Three Affiliated Tribes interest earnings from the Three Affiliated Tribe Docket Funds in the amount of \$438,541.54.


CERTIFICATION


