



**RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION**

- WHEREAS,** This nation having accepted the Indian Reorganization Act of June 18, 1934, and the Authority under said Act; and
- WHEREAS,** The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and the enrolled members thereof; and
- WHEREAS,** Title I, Chapter 1, Section 4.2 of the Fort Berthold Tribal Code specifically authorizes and directs the tribal Business Council to appoint licensed attorneys to each serve in the capacity of Associate Judges on a calendar year; and
- WHEREAS,** It is the considered judgment of the Tribal Business Council that the Judiciary of the Three Affiliate Tribes must maintain exceptionally qualified judicial officers to up hold the laws and customs of the Tribes; and
- WHEREAS,** The Tribal Business Council has selected **BJ Jones, Peter Furuseth and Terry Pechota and Robert Holte** to serve as Associate Judges in the Fort Berthold District Court during calendar year 2008; and
- NOW , THEREFORE , BE IT RESOLVED,** That the Tribal Business Council hereby assigns the respective appointees to each serve on a rotating basis as presiding Associate Judge during the calendar year 2008 quarters as follows:

If the current scheduled Associate Judge is unavailable then the court will go the next scheduled Associate Judge.



Resolution NO. 07-23-VJB

BE IT FURTHER RESOLVED, That the rate of compensation for each appointee shall be Five Hundred Dollars (\$500.00) per day per court session, in addition to reimbursement of documented travel expenses.

BE IT FURTHER RESOLVED, That the Tribal Business Council hereby directs the Fort Berthold District Court to prepare the appropriate consultant agreement for the respective appointee identified herein above, and to specify that the rate of compensation shall be Five Hundred Dollars (\$500.00) per day court session, in addition to reimbursement of documented travel expenses.
