

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

A Resolution entitled; "Appointment of <u>Vivian Hall</u> to the Gaming Commission of the Three Affiliated Tribes of the Fort Berthold Indian Reservation; <u>Mandaree Segment</u>."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, §1 of Article III of the Constitution and Bylaws of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to adopt resolutions regulating the procedures of the Tribal Business Council, other Tribal Government entities, and Tribal Officials; and
- WHEREAS, § 5 (I) of Article VI of the Constitution and Bylaws of the Three Affiliated Tribes authorizes the Tribal Business Council to manage all economic affairs and enterprises of the Three Affiliated Tribes; and
- WHEREAS, the Tribal Business Council has authority according to the terms of the said Constitution to manage the affairs of the Four Bears Casino & Lodge; and
- WHEREAS, The Three Affiliated Tribes own and operate a Class II and Class III Gaming facility known as the Four Bears Casino & Lodge; and
- WHEREAS, the Tribal Business Council of the Three Affiliated Tribes established the Three Affiliated Tribes Gaming Commission through Chapter 27 of the Code of Laws of the Three Affiliated Tribes of the Fort Berthold Indian Reservation; and
- WHEREAS, The Tribal Business Council of the Three Affiliated delegated the Primary responsibility of regulating the conduct of gaming on the Fort Berthold Indian Reservation to the Three Affiliated Tribes Gaming Commission; and
- WHEREAS, The Tribal Business Council duly approved Tribal Resolution #07-203-VJB on October 26, 2007 entitled "Restructuring of the Three Affiliated Tribes Gaming Commission"; which primarily discontinues the practice of salaried gaming commissioners and establishes thereafter per meeting stipend payments of no less than \$100 per meeting not to exceed \$500 per month; and

- WHEREAS, That such Tribal Resolution #07-203-VJB also mandates the appointment or reappointment of all respective Gaming Commissioners by no later than three months time or by subsequent date of January 26th, 2008 to duly complete such restructuring; and
- NOW, THEREFORE BE IT RESOLVED, That the <u>Mandaree Segment</u> Representative of the Tribal Business Council of the Three Affiliated Tribes hereby duly nominates the appointment of <u>Vivian Hall</u> to the Gaming Commission of the Three Affiliated Tribes.
- **BE IT FURTHER RESOLVED,** That the Tribal Business Council of the Three Affiliated duly approve the appointment of <u>Vivian Hall</u> to the <u>Mandaree Segment</u> position of the Gaming Commission of the Three Affiliated Tribes, which shall become effective immediately.
