



**RESOLUTION OF THE GOVERNING BODY  
OF THE THREE AFFILIATED TRIBES  
OF THE FORT BERTHOLD INDIAN RESERVATION**

*A Resolution entitled, "Child Support Budget Amendment to resolution 07-222-VJB."*

- WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and
- WHEREAS,** Pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS,** Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to administer any funds within the exclusive control of the Tribes to make expenditures from available Tribal funds for public purposes of the Tribes; and
- WHEREAS,** Pursuant to Article VI, Section 5 (l) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS,** The Tribal Business Council has established the TAT Division of Child Support Enforcement and authorized the Tribal DCSE to apply for the fully comprehensive OCSE Grant to become a fully operational Title IV-D program and this grant requires the Tribe to commit a non-federal matching share in the amount of ten percent of the federal grant amount; and
- WHEREAS,** The Tribal Business Council pursuant to Resolution 07-222-VJB authorized that the amount of \$28,933.40 for Fiscal Year 2008 be allocated to fulfill the ten percent non-federal matching share required by the grant provisions; and
- WHEREAS,** The TAT DCSE Start-up Grant has received a new ending date of on or about May 1, 2008, and the original budget submitted to the Tribal Business Council has been modified, which has resulted in a modification of the amount of the non-federal matching share required by the grant provisions; and

WHEREAS, The TAT DCSE has leased a larger office space to accommodate the growing needs of the program and added additional staff which has required a modification to the TAT DCSE FY08 budget; and

WHEREAS, The modification to the TAT DCSE FY08 budget results in a change in the ten percent non-federal matching share required by the grant provisions and the ten percent Tribal matching share is now \$30,502.44; and

WHEREAS, The TAT DCSE has been given approval to continue to utilize the remainder of their Start-up funding to operate on until the TAT DCSE becomes a comprehensive IV-D program.

NOW, THEREFORE, BE IT RESOLVED that the Tribal Business Council hereby authorizes that a ten percent matching share in the amount of \$30,502.44 for Fiscal Year 2008 be allocated to fulfill the ten percent non-federal matching share requirement of the above-mentioned grant provisions, with such allocation being subject to the availability of funds and to an agreement by all affected programs and parties to utilize the most in-kind matching funds as possible.

BE IT FURTHER RESOLVED that Resolution 07-222-VJB is hereby amended to be consistent with the above-mentioned amended budget for the child support enforcement program and modification in the ten percent matching share requirement amount.


CERTIFICATION


