

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Approval of the Three Affiliated Tribes – Tribal Oil and Gas Extraction Tax"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, the Three Affiliated Tribes Tax Commission has been empowered to administer the tax laws of the Three Affiliated Tribes to formulate and submit for approval to the full Tribal Business Council recommendations as to Tribal Taxes; and
- WHEREAS, the TAT Tax Commission has met and has forwarded to the Tribal
 Business Council for approval the "Tribal Oil and Gas Extraction Tax"
 that shall be assessed against the activity of extracting oil from the earth
 within the exterior boundaries of the Fort Berthold Reservation; and
- WHEREAS, the proposed "Tribal Oil and Gas Extraction Tax" shall be assessed against the lessee's or producer's interest and shall not be assessed against any allotted or tribal interest; and
- WHEREAS, the Tax Commission recommends the tax rate for the "Tribal Oil and Gas Extraction Tax" be assessed at two and one half percent (2 ½%) to be assessed on the extraction of oil and gas within the exterior boundaries of the Fort Berthold Reservation; and
- NOW, THEREFORE BE IT RESOLVED, the Tribal Business Council approves the "Tribal Oil and Gas Extraction Tax" at a rate of two and one half percent (2 ½%) of the value of the Lessee's or Producer's interest in the oil and gas extracted from the earth within the exterior boundaries of the Fort Berthold Reservation; and
