

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled: "Approval of Corporate Credit Card in the amount of \$100,000 for the Tribes Finance Department for Airline Travel with First International Bank and Trust of Williston, ND"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and
- WHEREAS, pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, pursuant to Article VI, Section 5 (l) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes Specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and

**WHEREAS,** The Tribe Has contracted with AAA Travel Agency for all tribal travel and AAA has requested that the Tribe provide a credit card for booking airline travel in the amount of \$100,000.

**NOW, THEREFORE BE IT RESOLVED,** that the Tribal Business Council hereby authorizes the Three Affiliated Tribes Finance Department to obtain a credit card with the credit limit of One Hundred Thousand Dollars (\$100,000) from First International Bank and Trust of Williston, ND; and negotiate any necessary terms including security for said credit card; and



**BE IT FURTHER RESOLVED,** that such cards shall be in the name of the Three Affiliated Tribes Finance Department and shall be used exclusively for airline travel with AAA Travel Agency.
