

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Appointment of Executive Officers of the Tribal Business Council of the Three Affiliated Tribes; the Mandan, Hidatsa, and Arikara – dated December 4th, 2008"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribe generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III, Section 5 of the Constitution and By-Laws of the Three Affiliated Tribes provides that within three (3) days after the installation of the successful candidates for Tribal Business Council positions, the Tribal Business Council shall meet and elect a Vice-Chairman, a Secretary, and a Treasurer from among its members; and
- WHEREAS, The Tribal Business Council is formally reorganizing upon completion of the November 4, 2008 Tribal Election duly held and certified by the Tribal Election Board; and
- WHEREAS, The Tribal Business Council, pursuant to a legal quorum has the authority to elect and appoint officers of the Tribal Business Council from among its membership; and
- NOW, THEREFORE BE IT RESOLVED, That, the Tribal Business Council, pursuant to its lawful authority and by majority vote of the Council Members does hereby appoint the following Tribal Business Council representatives as executive officers of the Tribal Business Council as follows:

BE IT FURTHER RESOLVED, that following the duly held and certified December 2, 2008

General Election for the Mandaree Segment Representative and the official swearing in of the Mandaree Segment Representative to the Tribal Business Council, the Tribal Business Council shall reconvene and elect from its own members a Vice Chairman, a Secretary and a Treasurer.
