

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Approval of Applications for a Loan and a Grant from the USDA Rural Development in the Amount of \$4,567,900.00 for the North Segment (New Town) Area 1 and 3 Water Distribution Project for the Fort Berthold Rural Water System."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, pursuant to Article VI, Section 5 (1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, Article VI Section 5 (a) of the Constitution provides that The Tribal Business Council shall have the power to manage the economic affairs of the Three Affiliated Tribes and administer any funds within the exclusive control of the Tribes and The Tribal Business Council thereby has the power to borrow funds that are necessary for the Tribe to continue exercising all of the powers of government; and
- **WHEREAS**, The Tribe and Tribal Business Council has established the Fort Berthold Rural Water System whose primary responsibility is to develop effective, efficient and safe, drinking water systems for the members of the Tribe on the Reservation; and



- WHEREAS, The Fort Berthold Rural Water System is proposing to construct a water distribution Project for the North Segment (New Town) Area 1 and 3 to be funded by a combination of USDA Rural Development grant and Loan funds through the Rural Development Water or Waste System Rural Utilities Service loan program and the Tribal Set-Aside Grant Program funding for a total project cost of \$4,567,900.00 and a portion of the grant will be funded from the American Recovery and Reinvestment Act of 2009 ("Recovery Act").
- WHEREAS, The Three Affiliated Tribes is eligible to apply for a loan and grant from the United States Department of Agriculture, (USDA) Rural Development, under the Water and Waste System Program in the combined amount of \$ 4,567,900.00 to be used for the water distribution project for the North Segment (New Town) Area 1 and 3 for the Fort Berthold Rural Water System of the Three Affiliated Tribes; and
- WHEREAS, Tribe is eligible to apply for grant funds in the amount of \$1,928,900.00 for the construction of the Project; and
- WHEREAS, The Tribe is eligible to apply for a loan in the amount of \$2,639,000.00 at an annual interest rate of 3.7500% over a forty year period to be repaid from annual appropriations of the Tribe as they become available for the balance of the Project cost; and
- WHEREAS, In order to obtain these grant and loan funds, the Tribe must submit a variety of forms required by the USDA, as per the attached, including:
 - 1. Form RD 1942-46, Letter of Intent to Meet Conditions
 - 2. 1940-1, Request for Obligation of Funds
 - 3. Form RD 400-1, Equal Opportunity Agreement
 - 4. For RD 400-4, Assurance Agreement

 - 6. AD 1047, Certification Regarding Debarment, Suspension, and Other Responsibility Matters Primary Covered Transactions

 - 8. RUS Bulletin 1780-28, Loan Resolution Security Agreement
 - 9. 1780-12, water and Waste Systems Grant Agreement
 - 10. A Tribal Resolution authorizing the Loan and Grant



- WHEREAS, The Tribal Business Council previously adopted Resolution 06-81-NH authorizing a loan and grant application to USDA Rural Development for the North Segment (New Town) Area 1 and 3 Distribution Project in the amount of \$3,307,280.00, however the project costs have since increased; and
- WHEREAS, The Tribal Business Council now modifies resolution 06-81-NH loan and grant application to USDA Rural Development for the North Segment (New Town) Area 1 and 3 Distribution Project to approve the new amount of funding of \$4,457,900.00, and
- WHEREAS, The Tribal Business Council has determined that, based on the interest rate and long-term payback of the loan, and in order to obtain the necessary funding for selected water supply and distribution projects for the Fort Berthold Rural Water System, it is in the Tribes' best interest to enter into and execute the aforementioned documents and Agreements with the USDA to apply for the loan and Grant for this Project; and
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby authorizes the application for a loan from the United States Department of Agriculture Rural Development in the amount of \$2,639,000.00 to be amortized over a forty year period at an annual interest rate of 3.7500% to be repaid from annual appropriations of the Tribe as they become available for construction of the North Segment (New Town) Area 1 and 3 Water Distribution Project of the Fort Berthold Rural Water System with the final loan documents subject to final approval of the Tribal Business Council; and;
- **BE IT FURTHER RESOLVED**, that the Tribal Business Council hereby authorizes the application for a grant from the U.S. Department of Agriculture in the amount of \$1,928,900.00 to be used for the North Segment (New Town) Area 1 and 3 Water Distribution Project for the Fort Berthold Rural Water System; and
- **BE IT FURTHER RESOLVED**, that the Tribal Business Council of the Three Affiliated Tribes hereby authorizes submittal of the following loan documents necessary to apply for the loan from Rural Development:

 - 2. 1940-1, Request for Obligation of Funds

BE IT FINALLY RESOLVED, that the Tribal Business Council hereby authorizes the Chairman, Vice-Chairman, Secretary and Treasurer of the Tribal Business Council to execute the aforementioned documents, as may be necessary, on behalf of the Three Affiliated Tribes of the Fort Berthold Reservation, and to further execute such other documents as may be necessary to obtain the aforementioned loan.
