

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- A Resolution entitled; "Appointment of Walter DeVille to the Fort Berthold Housing Authority Board of the Three Affiliated Tribes of the Fort Berthold Indian Reservation; serving the Chairman At-Large."
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, §1 of Article III of the Constitution and Bylaws of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to adopt resolutions regulating the procedures of the Tribal Business Council, other Tribal Government entities, and Tribal Officials; and
- WHEREAS, § 5 (1) of Article VI of the Constitution and Bylaws of the Three Affiliated Tribes authorizes the Tribal Business Council to manage all economic affairs and enterprises of the Three Affiliated Tribes; and
- WHEREAS, the Tribal Business Council has authority according to the terms of the said Constitution and NAHASDA (HUD) to manage the affairs of the Fort Berthold Housing Authority, but however the Tribal Business has delegated that authority to the Fort Berthold Housing Authority Board of Directors; and
- NOW, THEREFORE BE IT RESOLVED, That the At Large-Chairman Representation of the Tribal Business Council of the Three Affiliated Tribes hereby duly nominates the appointment of Walter DeVille to the Board of Directors of the Fort Berthold Housing Authority of the Three Affiliated Tribes.
- **BE IT FURTHER RESOLVED,** That the Tribal Business Council of the Three Affiliated duly approve the appointment of <u>Walter DeVille-At Large</u> position of the Board of Directors of the Fort Berthold Housing Authority of the Three Affiliated Tribes, which shall become effective immediately.
