



**RESOLUTION OF THE GOVERNING BODY  
OF THE THREE AFFILIATED TRIBES  
OF THE FORT BERTHOLD INDIAN RESERVATION**

*A Resolution entitled, "Additional Routes & Maintenance work to be included in the Revised Transportation Improvement Program "TIP" List."*

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and

**WHEREAS,** The constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** The Constitution and Bylaws of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council of the Three Affiliated Tribes to engage in activities on behalf of, and in, the interest of the welfare and benefit of the Three Affiliated Tribes, and the enrolled members thereof; and

**WHEREAS,** The Three Affiliated Tribes' Tribal Business Council recognizes the need for an alternate transportation system to provide access and services for the traveling public; and

**WHEREAS,** The Three Affiliated Tribes' Tribal Business Council has determined that the Bureau of Indian Affairs should proceed with the P.L. 93-638 process to contract with the Three Affiliated Tribes, to plan and design the construction of several highway and street projects; and

**WHEREAS,** The Three Affiliated Tribes does recognize the need and requirements by the Bureau of Indian Affairs via the Federal Highway Administration to develop and maintain a Transportation Improvement List (TIP); and

**WHEREAS,** The Three Affiliated Tribal Business Council acknowledges that projects may be moved up or down the priority list depending on the availability of funding and additional co-operative funding from other governments and agencies.

**NOW THEREFORE BE IT RESOLVED,** The Three Affiliated Tribes Tribal Business Council recommends that the Transportation Improvement Program (TIP) include these Routes, Road Projects, Maintenance Work List as follows:



**Mandaree- BIA Routes 0017**  
**White Shield- BIA Routes 0301, 0003, 1820, 0024**  
**Twin Buttes- BIA Routes 0221, 0222, 0026**  
**North Segment- BIA Routes 0601, 0602, 0603**  
**Route 5300 Four Bears paving project Earth Lodge Village**  
**Route 3800 Parshall Trailer Park grade, drain, curb & gutter, pavement**

**Reservation Wide Reconstruction of Paved Roads**

**BIA Route 0002 – 4 Bears Farm Road**  
**BIA Route 0006 – Shell Creek Road**  
**BIA Route 0012 – Heart Butte Mandaree**  
**BIA Route 0018 – White Shield Old Garrison Trail**  
**BIA Route 0022 – Twin Buttes New Ree**  
**BIA Route 0221 – Twin Buttes**


**CERTIFICATION**


