



## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution entitled, "Public Transportation on Indian Reservations Program; Tribal Transit Program Grant"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and
- WHEREAS, pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, pursuant to Article VI, Section 5 (1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- **WHEREAS**, the Tribal Business Council has authority according to the terms of the said Constitution to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- **NOW THEREFOR IT BE RESOLVED,** the Tribal Business Council hereby supports the intent of the Tribal Transit Committee to apply for the Public Transportation on Indian Reservations Grant, Tribal Transit Grant Program; and
- **BE IT FINALLY RESOLVED THAT,** the Three Affiliated Tribes hereby authorizes the formation of the Tribal Transit Committee to act as the guiding body to the formation of a Tribal Transit Plan; and this committee shall consist of representatives of the Tribal Roads Department, the Tribal Elder Nutrition Department, the Tribal CEDS Department, the Tribal Law Enforcement and the Fort Berthold Occupant Protection Committee and a minimum of two community representatives including a staff member of the Fort Berthold Community College.



## CERTIFICATION
