

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Engagement of Robert W. Baird & Co. Incorporated as the Sole Managing Underwriter / Placement Agent for General Obligation Taxable and Tax Exempt Bonds for the Three Affiliated Tribes"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes was adopted by membership of the Tribes on May 15th, 1936 pursuant to the Indian Reorganization Act of 1934 and duly approved by the Secretary of Interior; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Tribal Business Council desires to refinance the current tribal obligations, new working capital needs and new construction needs into a single financial instrument; and
- WHEREAS, The Tribal Business Council has reviewed and now finds it desirable to enter into an agreement with Robert W. Baird & Co. Incorporated as the Sole Managing Underwriter / Placement Agent for General Obligation Taxable and Tax Exempt Bonds for the Three Affiliated Tribes.
- NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby approves the (attached) Engagement Letter with Robert W. Baird Co. Incorporated and its managing director David W. Noack to serve as the Sole Managing Underwriter / Placement Agent for General Obligation Taxable and Tax Exempt Bonds for the Three Affiliated Tribes; and
- **BE IF FURTHER RESOLVED**, the Tribal Business Council authorizes and directs the Tribal Chairman and the Tribal Treasurer to execute the Engagement Letter and any other necessary documents to carry out the intent of this Resolution.
