

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "<u>Approval of Tribal Chairman – Tex G. Hall, Board Appointments for</u> <u>Fort Berthold Community College Board, FBHA Board, TERO Board, and Communications</u> <u>Board</u>".

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, The Tribal Business Council has established several Tribal Boards and Commissions by tribal ordinance and charters to oversee and administer various tribal programs and entities on the Fort Berthold Indian Reservation, including the MHA Communications Board of Directors, the TERO Commission, The Fort Berthold Housing Authority Board of Commissioners and the Fort Berthold Community College Board of Directors; and
- WHEREAS, Pursuant to the charters and ordinances establishing these boards and commissions such boards and commissions consist of seven members with one member appointed from each Tribal Council Segment representative and one from the Tribal Chairman to serve four year terms consistent with the term of the appointing council member; and
- WHEREAS, A general election was held on November 2nd, 2010 for the Tribal Chairmanand Tex G. Hall was certified as the winner of the Tribal Chairman position and has been duly sworn into office and vacancies have therefore been created on the TERO Commission, the Fort Berthold Housing Authority Board of Commissioners, the Fort Berthold Community College Board of Directors and the MHA Communications Enterprises Board of Directors. Chairman Tex G. Hall has selected the appointees to these Boards; and



**NOW, THEREFORE BE IT RESOLVED**, That the Tribal Business Council hereby ratifies the following appointments to the following Boards and Commissions for the Tribal Chairman:

**BE IT FINALLY RESOLVED**, that the above changes of Fort Berthold Community College Board, the TERO Commission, the Fort Berthold Housing Authority Board of Commissioners, the Fort Berthold Community College Board of Directors, MHA Communications Enterprises Board of Directors. Chairman Tex G. Hall has selected the appointees to these Boards; and they supersede the previous appointments to this Board of Directors.
