

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled: "Approval of Allocation of two (2%) percent of all royalties received from Spotted Hawk Development LLC Royalties for benefit and use by MHA Holdings Incorporated pursuant to Resolution 08-120 BLB (July 16, 2008)"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribe generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Tribal Business Council has previously approved an oil and gas lease for approximately 31,983 acres by Tribal Business Council Resolution 08-120 (July 16, 2008); and
- WHEREAS, Resolution 08-120 contained a provision that the Tribe shall allocate funds in an amount not to exceed two (2%) percent of said royalty payments to MHA Holdings Incorporated ("MHA Holdings"), a wholly owned tribal entity; and
- WHEREAS, MHA Holdings is a tribal company whose purpose is to develop economic opportunities for the Three Affiliated Tribes; and
- WHEREAS, The Tribe has previously assisted MHA Holdings financially through debt repayment and other assistance; and
- WHEREAS, MHA Holdings desires to utilize its two (2%) royalty share to reimburse the Tribe and other lenders to reduce and eliminate its debt and to provide funds for other economic development projects.
- NOW THEREFORE BE IT RESOLVED, The Tribal Business Council, pursuant to its action via Tribal Resolution 80-120 (July 16, 208) now allocates for use by MHA Holding Incorporated an amount not to exceed two (2%) of the total royalties received by the Tribe pursuant to the lease(s) and acreage described in Tribal Resolution 08-120 (July 16, 2008); and
- **BE IT FURTHER RESOLVED,** Any funds so allocated to MHA Holdings shall first be applied to all amounts owed to the Tribe and other lenders prior to any funds being made available to MHA Holdings; and



BE IT FINALLY RESOLVED, MHA Holdings shall not be entitled to any other portion of any other royalties received through Spotted Hawk Development LLC or any other oil lease except for the specific acreage described in Tribal Resolution 08-120 (July 16, 2008).
