



**RESOLUTION OF THE GOVERNING BODY
OF THE THREE AFFILIATED TRIBES
OF THE FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, “*Education Standards and Practices Board Certification of the North Dakota American Indian Languages and Cultural Instructor.*”

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under Act: and

WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Pursuant to Article VI, Section 5 (1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal Agencies and Tribal Officials of the Reservation; and

WHEREAS, The policy of the Tribal Business Council is to promote educational development and growth for our children in the instruction of our Mandan, Hidatsa and Arikara Languages, Cultures and Traditions, essential elements of the life, cultural and identity of the Three Affiliated Tribes; and

WHEREAS, The New Town Public School District shall include the instruction of the Hidatsa and Arikara languages and cultures from grades Kindergarten through twelfth grade and for high school graduation credit; and

WHEREAS, The Fifty-Fourth Legislative Assembly of North Dakota, has passed legislation of Senate Bill No. 2491, a bill to create and enact a new section to Chapter 15-38 of the North Dakota Century Code:

Education Standards and Practices Board Certification of North Dakota American Indian Language Instructor. The education standards and practices board may certify and individual as an instructor of North Dakota American Indian Languages and culture of the individual is recommended for certification to teach North Dakota Native Languages by the indigenous language boards created by the four North Dakota Tribal Governments of the State’s Reservations and if the individual:

- 1. Displays competence in North Dakota American Indian languages and culture and has successfully completed a three semester hours course in classroom instruction at a tribal college or other institution of higher education; or



2. Holds a baccalaureate degree and has knowledge of and experience in North Dakota American Indian language and cultures

WHEREAS,

Charles Moran Sr. meets criteria #1 of the North Dakota Century Code, Chapter 15-38-18.1. Charles attended Fort Berthold Community College in the spring of 2010 complete a course in Classroom Management. He had worked with children from preschool to twelfth grade at the Three Affiliated Tribe's Growth and Development as Administrator and Activity Coordinator for two years, Fort Berthold Housing Authority's Drug Elimination Program as Director and Cultural Coordinator for five years and the Three Affiliated Tribe's Boys and Girls Club's as Co-Administrator and Cultural Coordinator for six years; and

WHEREAS,

Charles is very active in all six Districts of the Fort Berthold Indian Reservation as a Traditional Announcer for the Mandan, Hidatsa and Arikara people in Community Socials, Celebrations and Ceremonies of the Three Tribes for the past 20 years. He understands, teaches the Traditions, Cultures, History and Origins of the Three Tribes. Charles will be employed with the New Town School District this fall 2010-2011 School year as the Cultural and Traditions Instructor.

NOW THERE FOR IT BE RESOLVED, that the Three Affiliated Tribes Tribal Business Council under its authority certifies that Charles Moran Sr. meets the requirements under as a Certified Language, Cultural and Traditions Instructor.


