

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Approval of Four Bears Tribal Council Representative Change of Board Appointment for Fort Berthold Community College Board of Directors"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and

the authority under said Act and having adopted a Constitution and By-laws

under said Act; and

WHEREAS, Article III, of the Constitution of the Three Affiliated Tribes provides that the

Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Tribal Business Council has established several Tribal Boards and

Commissions by tribal ordinance and charters to oversee and administer various Tribal programs and entities on the Fort Berthold Indian Reservation, including the MHA Communications Board of Directors, the TERO Commission, the Fort

Berthold Housing Authority Board of Commissioners, the Fort Berthold Community College Board of Directors and Weed Control Board; and

WHEREAS, Pursuant to the charters and ordinances establishing these boards and

Commissions; such boards and commissions consist of seven members with one Member appointed from each Tribal Council Segment representative and one from the Tribal Chairman to serve four year terms consistent with the term of

the appointing council members; and

WHEREAS, V. Judy Brugh, Four Bears Council Representative has appointed by resolution

various members to such Boards with one being Harry Sitting Bear, Harry Sitting

Bear has since resigned from the Fort Berthold College Board of Directors, and

NOW, THEREFORE BE IT RESOLVED, that the Tribal Business Council hereby ratifies the appointment of Maggie Young Bear to the Fort Berthold Community College Board; and







BE IT FURTHER RESOLVED, that the above appointed Board member shall serve for a period consistent with the term of the office of the Four Bears Segment Representative unless removed prior to the four year term, according to the Tribal ordinance establishing said Boards.
