

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution Entitled: <u>Approval of Tribal Chairman Tex G. Hall, Board Appointments for the Gaming Enterprise Advisory Board</u>"
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
  - WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
  - WHEREAS, Article VI, Section 5 (I) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
  - WHEREAS, The Tribal Business Council has established several Tribal Boards and Commissions by tribal ordinance and charters to oversee and administer various tribal programs and entities on the Fort Berthold Indian Reservation, including the Gaming Enterprises Advisory Board; and
  - WHEREAS, Pursuant to the charters and ordinances establishing these boards and commissions such boards and commissions consist of seven members with one member appointed from each Tribal Council Segment representative and one from the Tribal Chairman to serve four year terms consistent with the term of the appointing council member; and
  - WHEREAS, A general election was held on November 2nd, 2010 for the Tribal Chairmanand Tex G. Hall was certified as the winner of the Tribal Chairman position and has been duly sworn into office and vacancy has been created on the Gaming Enterprises Advisory Board Chairman Tex G. Hall has selected Mark Fox to serve on this Board and
- **NOW, THEREFORE BE IT RESOLVED**, That the Tribal Business Council hereby Ratifies the appointment of Mark Fox to the Gaming Enterprises Advisory Board for a four year term.
