

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Enforcement of the Elder Homes Program Monthly Rate, Optional Conveyance of Elder Homes and Abolishment of the Elder Homes Program"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, The Tribal Business Council previously established the Elder Homes Program that provided affordable housing for selected elders in each Segment; and
- WHEREAS, The recipients of said homes were required to sign an occupancy agreement which set forth monthly payments in the amount of \$150.00 to occupy said home and provide for a revolving fund source for the Tribal Housing Services Program to continue to construct more elder homes as funds are available; and
- WHEREAS, The Elders home program was intended to be on a rent to own basis; and
- WHEREAS, A motion entitled "Elder Home Payments \$50.00" was approved at a Special Tribal Business Council Meeting on August 27, 2008 that reduced the Elder Homes Program monthly payment to \$50.00 for existing Elder Homes; and
- WHEREAS, The Tribal Housing Services Program recommends two options for the current program participants:

Option 1 – Enforce the motion to require the recipients of the Elder Homes to pay a monthly payment of \$50.00 to cover the cost of dwelling insurance and administration. This option does not allow for the participant to own the home.



 $\underline{\text{Option 2}}$  – Convey the home to the recipient with full disclosure of the responsibility to pay for the associated individual tax liability. This option allows the participant full ownership of the home; and

WHEREAS, The Tribal Housing services Program has determined that the Elder Homes Program will not be able to adequately fund any future housing construction utilizing the current accounts receivables for the Program and therefore recommends that the Elder Homes Program be abolished and no further construction for Elder Homes be funded under the Program.

NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council does hereby accept and approve the two option recommendations of the Tribal Housing Services Program to enforce the Elder Homes Program monthly payments of \$50.00 per month beginning July 1, 2011, payable to the Tribal Housing Program OR offer the conveyance of home to recipient with full disclosure and acceptance of individual tax liability by the elder home owner; and;

BE IT FURTHER RESOLVED, that the Tribal Business Council does hereby accept and approve the recommendation of the Tribal Housing Program to abolish the Elder Homes Program and prohibit any future housing construction under the guidelines of this Program; and

**BE IT FURTHER RESOLVED,** that the terms of this resolution do not apply in any manner to any home constructed under the 210 home initiative regardless of whether such homes may have been delineated as an elder home; and

BE IT FINALLY RESOLVED, that the Elder Homes which are included in this resolution and for which it applies are as follows:
