

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution entitled, "Maternal Child Health Grant"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribe generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, pursuant to Article VI, Section 5 (1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regarding the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, the Tribal Business Council has authority according to the terms of the Constitution to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, the Minne-Tohe Health Centers currently do not have the services of a licensed pediatrician; and
- WHEREAS, the Three Affiliated Tribes qualifies for a pass through grant under the division of the Maternal Child Health/Title V program in the amount of \$14,887 yearly; and
- WHEREAS, these funds will be made available starting in July 2011.
- **NOW THEREFORE BE IT RESOLVED,** by the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation, as follows:
  - 1. The Maternal Child Health / Title V program grant will be applied for and held under the Minne-Tohe Health Centers for all future years.
  - 2. The funds for this grant will be utilized to pay for a pediatrician to provide services to the children of the Three Affiliated Tribes.
