



**RESOLUTION OF THE GOVERNING BODY
OF THE THREE AFFILIATED TRIBES
OF THE FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled: "Approval of our Four Bears Segment Tribal Council Representative's Change of Board Appointment for TERO."

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and

WHEREAS, Article III, of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Article VI, Section 5 (1) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and,

WHEREAS, The Tribal Business Council has established several Tribal Boards and Commissions by tribal ordinance and charters to oversee and administer various tribal programs and entities on the Fort Berthold Indian Reservation, including the MHA Communications Boards of Directors, the TERO Commission, the Fort Berthold Housing Authority Board of Commissioners, the Fort Berthold Community College Board of Directors and Weed Control Board; and,

WHEREAS, Pursuant to the charters and ordinances establishing these boards and commissions such boards and commissions consist of seven members with one member appointed from each Tribal Council Segment representative and one from the Tribal Chairman to serve four year terms consistent with the term of the appointing council member; and

WHEREAS, V. Judy Brugh is the Four Bears Segment Council Representative and previously selected Everett Hall to serve on the TERO Commission, but due to his place of employment Council woman Brugh has determined there is a conflict of interest for Mr. Hall to continue serve on the TERO Commission and Council Woman Brugh has made a decision to replace Mr. Hall with Robert Brugh Jr.





RESOLUTION NO. 11 105-VJB

NOW, THEREFORE BE IT RESOLVED, that the Tribal Business Council hereby ratifies The appointment of Robert Brugh, Jr. to serve as the Four Bears Segment Representative to TERO Commission; and

BE IT FURTHER RESOLVED, that said appointment shall be for a term consistent with the term of office of the Four Bears Segment Representative to the Tribal Council.


