

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled "Approval of the Conditional Relinquishment of Nickolas David Jetty Enrollment # 301U-10934 from Membership of the Three Affiliated Tribes"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- **WHEREAS,** The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- **WHEREAS,** The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and
- WHEREAS, Vivian Jetty, legal guardian of Nickolas David Jetty, a minor, has requested a conditional relinquishment of his membership from the Three Affiliated Tribes, and has applied for membership with the Spirit Lake Sioux Tribe; and
- WHEREAS, A copy has been received of application confirmation from the Spirit Lake Sioux Tribe.
- **WHEREAS,** Nickolas David Jetty's relinquishment from the Three Affiliated Tribes will become final on the day the Spirit Lake Sioux Tribe accepts Nickolas David Jetty as a member of their tribe.

NOW THEREFORE BE IT RESOLVED, by the Tribal Business Council of the Three Affiliated Tribes that Nickolas David Jetty is hereby conditionally relinquished from The official membership roll of the Three Affiliated Tribes; and





BE IT FINALLY RESOLVED that the Spirit Lake Sioux Tribe, shall be provided with a certified copy of this Resolution.

CERTIFICATION
