

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: <u>Request to Secretary of Interior to Acquire Certain Tribal Fee Lands into Trust Status on Behalf of the Three Affiliated Tribes</u>"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribe generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Article VI, Section 5 (1) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and

WHEREAS, Pursuant to Article VI, Section 5 (i) of the Constitution the Tribal Business Council has the authority to make assignments and leases of tribal lands and otherwise manage tribal lands, interests in tribal lands and property upon such lands in conformity with Article IX of the Constitution; and;

WHEREAS, The Three Affiliated Tribes owns certain fee lands in McKenzie County North Dakota which are adjacent to the Fort Berthold Indian Reservation and are described as: DUNN COUNTY:

WHEREAS, Said fee lands include some 8000 plus acres of land which were purchased in 1999 and are currently used for ranching and tourism and said lands are located adjacent to the Fort Berthold Indian Reservation; and

WHEREAS, The Indian Reorganization Act, 25 USC § 465 authorizes the Secretary of Interior to acquire into trust any interest in lands... within or without existing Indian Reservations; and

WHEREAS, 25 CFR § 151.3 provides that land not held in trust or restricted status may be acquired for a Tribe when such acquisition is authorized by an act of Congress and approved by the Secretary of Interior; and


WHEREAS, 25 CFR 151.3 (a) (1) and (2) further provides that the land may be acquired for a tribe in trust status when the property is located within the exterior boundaries of the Tribe's Reservation or adjacent thereto and when the Tribe already owns an interest in the land; and

WHEREAS, 25 CFR § 151. 3 (a (3) further provides that land may be acquired in trust when the Secretary determines that the acquisition of the land is necessary to facilitate tribal self-determination, economic development or Indian Housing; and

WHEREAS, 25 CFR § 151.9 provides that an Indian Tribe desiring to acquire land in trust status shall file a written request for approval of such acquisition with the Secretary which identifies the parties, a description of the land and other information which would show that the acquisition comes within the terms of Part 151.3; and

WHEREAS, The Tribal Business Council believes that the proposed that acquisition meets the requirements of 25 CFR part 151.3 in that the property proposed to be acquired is adjacent to the Fort Berthold Reservation and the Tribe owns an interest in it and the acquisition is necessary to further tribal self-determination; and

WHEREAS, The Tribal Business Council has determined that it is in the best interest of the Tribes to request that the property herein described be acquired by the Secretary into trust status



NOW THEREFORE BE IT RESOLVED, pursuant to 25 USC § 465 and 25 CFR Part 151 that the Tribal Business Council hereby request that the Secretary of Interior acquire the following described fee land into trust status on behalf of the Three Affiliated Tribes: DUNN COUNTY:

BE IT FURTHER RESOLVED, that the Tribal Business Council hereby further authorizes the transfer of title to the land described above to the United States Department of Interior to be held in trust for the benefit of the Three Affiliated Tribes, and requests that the Department of Interior perform its trust responsibility and expedite the process to place the land described above in trust status with the United States; and

BE IT FINALLY RESOLVED, that the Tribal Chairman is hereby authorized to take such further actions as are necessary to carry out the terms and intent of this resolution.
