

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Approval of an Extension of the \$9,500,000 loan with Starion Financial, and Authorization for the Chairman, Treasurer, or Secretary to execute all Necessary Loan Documents"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes ("Tribes") generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council ("Council") is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribe; and
- WHEREAS, The Tribe has an existing loan from Starion Financial ("Starion") in the amount of \$9,500,000 (the "Loan") which is evidenced by a promissory note dated November 25, 2009 (the "Note"); and
- WHEREAS, The Loan and the Note matured on November 20, 2011, and the Tribal Business Council finds that it would be in their best interests to enter into a amendment to the Note extending the maturity date of the Loan and the Note to November 20, 2012.
- NOW THEREFORE BE IT RESOLVED, the Tribal Business Council of the Three Affiliated Tribes pursuant to its constitutional authority hereby authorizes the Tribe to enter into an amendment extending the maturity date of the Loan and the Note with Starion Financial to November 20, 2012 with the following terms and conditions:

1.	Loan Amount:	\$9,500,000
2.	Interest rate	3.25% fixed
3.	Maturity Date	11-20-2012

4. Collateral Tribes existing CD held at Starion

5. CD Interest 0.80%
6. Origination Fee \$9,500.00





BE IT FURTHER RESOLVED, that the Tribal Business Council hereby approves the Amendment to the Promissory Note provided to the Tribal Business Council under the terms and conditions set forth therein with such additions, deletions or other modifications as any of the authorized signers identified below agree to in their sole discretion; and

BE IT FINALLY RESOLVED, that the Tribal Business Council hereby authorizes the Tribal Chairman Tex G. Hall, the Tribal Treasurer Mervin Packineau, or the Tribal Secretary V. Judy Brugh, individually, to sign and execute all loan documents (with such additions, deletions or other modifications as any of the authorized signers may agree to in their sole discretion) necessary to effectuate the amendment and extension authorized pursuant to this resolution and to deliver all such certificates, documents or other agreements to take all actions necessary to effectuate the amendment and extension authorized pursuant to this resolution.
