

OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Approval and Ratification of Renewal of the Existing \$14,000,000 Revolving Line Authorization for the Chairman and Treasurer to Execute all Necessary Loan Documents. of Credit with BNC Bank of Bismarck, North Dakota for General Operating Purposes of the Tribes and

- WHEREAS authority under said Act and having adopted a Constitution and By-Laws pursuant to said This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the
- WHEREAS welfare and benefit of the Tribes and of the enrolled members thereof, and The Constitution of the Three Affiliated Tribe generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the
- WHEREAS Business Council is the governing body of the Tribes; and Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal
- WHEREAS Article VI, Section (I) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies; and
- WHEREAS and to make expenditures from available Tribal funds for public purposes of the Tribes. the Tribal Business Council to administer funds within the exclusive control of the Tribes Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes authorizes and
- WHEREAS shortfalls for tribal government operations; and by the Tribe at the same time as tribal expenses become due and this creates budgetary with tribal government expenditures and that incoming revenues are not always received The Tribal Business Council finds that the revenues of the Tribe do not always coincide
- WHEREAS, deposit with the "Bank" and said line of credit matured on or about October 20, 2011; In order to meet these budgetary shortfalls in funding tribal government operations, the \$14,000,000 line of credit in 2010 which is secured by \$14 million dollar certificate of BNC Bank of Bismarck, North Dakota (hereinafter, the "Bank") extended the Tribe a
- WHEREAS. The Tribal Business Council further finds that it would be a prudent and good business practice to renew the existing line of credit of \$14,000,000 with the "Bank" to be utilized by the Tribe for governmental purposes in order to bridge the gap between the payment of expenses and the receipt of revenues; and

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes pursuant to its constitutional authority hereby authorizes and/or ratifies the renewal of the \$14 million revolving line of credit with BNC Bank of Bismarck, N.D. under the following terms and conditions:

Section 1. Approval and Authorizations

- 1.1 The Tribal Business Council hereby determines that the foregoing proposed actions are in the public interest and promote the welfare of the Tribe.
- 1.2 The Tribal Business Council hereby approves and/or ratifies the Financing Terms, in so far as they require Tribal approval, and the Tribe's execution, delivery and performance of all Loan Documents, Assignment Agreements and any other related documents reasonably necessary to effect the Loans (the "Loan Documents") in such forms as are approved by an Authorized Representative (defined below) and legal counsel for the Tribe, which approvals shall be deemed to have been conclusively given upon the execution of the Loan Document by an Authorized Representative.
- 1.3 The Chairman, Secretary, or Treasurer of the Tribe, individually or together with any other person who under the laws of the Tribe are permitted to act on behalf of the Tribe, (each, an "Authorized Representative") are hereby authorized and directed to execute the Loan Documents, and to execute such other documents and take such actions as are required or desirable to effect the purposes of this Resolution.
- 1.4 All actions taken by any Authorized Representative pursuant to the authority granted in Resolution 11-042-VJB approved by the Tribal Business Council on April 14, 2011 and in furtherance of the renewal of the line of credit as contemplated herein are hereby approved, adopted and ratified in all respects.

Section 2. Limited Waiver of Sovereign Immunity; Jurisdiction and Arbitration.

Provisions in the Loan Documents relating to the following matters are hereby expressly authorized, approved, ratified and adopted as the law of the Tribe with respect to the Loans; so long as such provisions substantially comply with the terms set forth in Section 3 below, or in the drafts of the Loan Documents attached hereto as Exhibit A:

- 2.1 The limited waivers of sovereign immunity, the consents to jurisdiction and waivers of the doctrines of abstention and exhaustion of tribal remedies; and
- 2.2 The obligation to resolve disputes related to the Loans by binding arbitration.
- 2.3 The choice of governing law with respect to the financing transactions with BNC National Bank shall be the North Dakota Uniform Commercial Code together with other North Dakota and federal law applicable to financing and secured transactions.

Section 3. Minimum Terms of the Loan Documents

The Chairman is hereby authorized to negotiate the terms of the revolving line of credit with 3.1 BNC National Bank of Bismarck, ND and execute the same along with the other authorized representatives provided that terms are included in the Loan Documents are similar or competitive with the following:
