**RESOLUTION OF THE GOVERNING BODY
OF THE THREE AFFILIATED TRIBES
OF THE FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled, "Tribal Business Council Approval and Certification for the FY-012 Grant Application in the amount of \$900,000.00 for the ICDBG Grant Program for the Mandaree West Segment for Infra-Structure"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and

WHEREAS, pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the tribes and of the enrolled members thereof; and

WHEREAS, pursuant to Article VI, Section 5 (l) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and

WHEREAS, Article VI, Section 5 (d) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to negotiate with Federal, State and local governments on behalf of the Tribe and to advise and consult with representatives of the interior Department on all activities that may affect the Fort Berthold Reservation; and

WHEREAS, The U.S. Department of Housing and Urban Development (HUD) for the Indian Community Development Block Grant (ICDBG) program has announced funding for 2011, and

WHEREAS, The Tribe has authority to submit applications to the U.S. Department of Housing and Urban Development (HUD) for the Indian Community Development Block Grant (ICDBG) program and the Tribal Business Council has decided that the first priority for the ICDBG Grant application for FY-12 shall be to build infrastructure for the, Mandaree, West Segment; and

WHEREAS, Pursuant to Resolution No. 05-97-NH the Tribe has adopted, acknowledged, and accepted the Maintenance and Operation Plan required by HUD for all proposed community facilities and commits to providing annually the necessary financial support in the amount of \$30,000.00 for these responsibilities: and

NOW, THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby authorizes the FY -2012 ICDBG Grant application in the amount \$900,000 to be used to build infrastructure for the Mandaree- West Segment; and

BE IT FURTHER RESOLVED, that The Tribal Business Council hereby certifies that the demographic data submitted with the FY 2012 ICDBG grant application has been systematically collected, and is systematically reliable and feasible and is independently verifiable; and

FURTHER, IT BE RESOLVED, that the Tribal Business Council hereby certifies that the Mandaree Community is the Priority for FY-2012 ICDBG and that it will provide a cash match of over 25% of the total project cost in the amount of \$300,000 in compliance with the ICDBG grant requirements for the FY- 2012 application (total grant request is \$900,000 and 25% plus cash match of \$300,000= \$1,200,000.00); and

FURTHER IT BE RESOLVED, That the Tribal Business Council hereby authorizes Tribal Chairman, Tex G. hall and Tribal Secretary V. Judy Brugh to sign and certify all agreements, applications forms and other documents necessary for said grant application; and

FINALLY BE IT RESOLVED, The Three Affiliated Tribes hereby adopts and adheres to all codes of conduct, financial management, procurement and internal control policies and procedures in compliance with 24 CFR Part 84 and 85; 24 CFR part 1003 in the administrations of all ICDBG projects


