

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Makes Cents Inc. and First Cents Inc. Consumer Loan Agreements"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes ("Tribes") generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council ("Council") is the governing body of the Tribes; and
- WHEREAS, The Three Affiliated Tribes ("Tribes") has determined that it is in the best economic interest, pursuant to its inherent sovereignty and the Constitution and By-Laws, and on behalf of and in the interests of the welfare and benefit of the Tribes and of the enrolled members thereof to pursue Tribal economic development opportunities through and with the formation of separate Tribal corporation under Tribal authority and law; and
- WHEREAS, the Council has formed and organized Makes Cents Inc. and First Cents Inc. as Tribal corporations under Tribal authority and law to pursue such economic development opportunities as wholly owned Tribal entities; and
- WHEREAS, because the Tribes and its members have routinely suffered from economic depression and slow economic growth, the purpose of the Makes Cents Inc. and First Cents Inc. is to promote the self-sufficiency of the Tribes and its members and families, and to address the socio-economic and cultural needs of the Tribes, its members, and its community; and
- WHEREAS, the Tribes established Makes Cents Inc. and First Cents Inc. to build capital within the Tribal community, which capital will subsequently be dispersed to the Tribes, and used in the Tribes' governmental discretion for the benefit of its members, and the community through Tribal initiatives and Tribal governmental programs. The increase in capital, as well as the initiatives and programs funded by the increase in capital, will guarantee that the Tribes can continue to care for itself, its members, and its community by promoting greater self-determination, political and social autonomy and cultural rejuvenation and survival; and



- WHEREAS, the Tribes desires to pursue, through MHA Systems Incorporated, Makes Cents Inc. and First Cents Inc. and other wholly owned Tribal entities that may be hereafter formed, an eCommerce based infrastructure including an internet-based consumer loan business and provision of financial services related thereto (the "Business"); and
- WHEREAS, the Tribes, through Makes Cents Inc. and First Cents Inc., desire to authorize the transaction documents by which Makes Cents Inc. and First Cents Inc. will make consumer loans to customers of Makes Cents Inc. and First Cents Inc.; and
- NOW THEREFORE BE IT RESOLVED, that the Council approves the attached loan documents (collectively the "Consumer Loan Agreements") that will be used in connection with loans by and between Makes Cents Inc. and First Cents Inc. and their customers; and
- BE IT FURTHER RESOLVED, that the Council, pursuant to its inherent sovereign powers and the powers vested to the Council, hereby expressly and unequivocally waives the sovereign immunity of Makes Cents Inc. and First Cents Inc., but only insofar as described in the Consumer Loan Agreements as attached hereto and approved hereby. Such action is deemed necessary and desirable as a material inducement for the non-tribal party to enter in to such agreements with Makes Cents Inc. and First Cents Inc.; and
- BE IT FINALLY RESOLVED, the Council, on behalf of the Tribes, having the power and authority to delegate the responsibility to approve, execute, deliver and perform its interest under the agreement(s) referenced herein to the Board of Directors of Makes Cents Inc. and First Cents Inc. and their respective officers which by the formation and organization of Makes Cents Inc. and First Cents Inc. the Council has intended and did indeed accomplish, hereby intends and acknowledges that the Board of Directors and the proper officers, as the case may be, of Makes Cents Inc. and First Cents Inc. are authorized to make such modifications, amendments and revisions as are deemed necessary and desirable and to provide for the execution of such agreement(s) described herein for the benefit of Makes Cents Inc. and First Cents Inc. and to take such further actions as are deemed necessary or desirable to carry out the terms and intent of this resolution and the purpose for which MHA Systems Incorporated, Makes Cents Inc. and First Cents Inc. were formed and organized, provided however that such authority does not apply with regard to the limited waiver of sovereign immunity provisions contained in such or any other agreement(s), it being understood that only the Council has authority to expressly and unequivocally waive the sovereign immunity of Makes Cents Inc. and First Cents Inc. or other tribal instrumentalities and to authorize and approve modifications, amendments or revisions thereto.



## CERTIFICATION

I, the undersigned, as Secretary of the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Indian Reservation hereby certify that the tribal Business Council is composed of seven (7) members of whom five (5) constitute a quorum, <u>5</u> were present at a Regular Meeting thereof duly called, noticed, convened and held on the <u>14th</u> day of <u>June</u>, 2012, that the foregoing Resolution was duly adopted at such meeting by the affirmative vote of <u>5</u> members, <u>0</u> members opposed, <u>0</u> members abstained, <u>0</u> members not voting, and that said Resolution has not been rescinded or amended in any way.
