

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled, "Grant Approval to the Red Sage Organization"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes was adopted by membership of the Tribes on May 15th, 1936 pursuant to the Indian Reorganization Act of 1934 and duly approved by the Secretary of Interior; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Tribal Business Council recognizes the Red Sage Organization's non-profit purposes and its activities as beneficial to the health and welfare of the Fort Berthold Reservation; and
- WHEREAS, The Red Sage Organization has recently received 501(c)(3) Non-Profit Status and has opened a full-time office to carry out its mission; and
- WHEREAS, In previous years, the Tribal Business Council has approved grants to support the organization's Annual Four Bears Bridge Benefit Swim.
- **NOW, THEREFORE, BE IT RESOLVED**, that pursuant to Article VI, Section 5 of the Three Affiliated Tribes Constitution, the Tribal Business Council does hereby approve, by formal resolution, a grant in the amount of \$1,000.00 per mile not to exceed \$12,000.00 to the Red Sage Organization.
