A Resolution Entitled “Approval of the Conditional Relinquishment of Dakota James Young Bird Enrollment #301U-12588 from Membership in the Three Affiliated Tribes”

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and

WHEREAS, Stewart John Young Bird and Claudette Rose Iron Shield, parents of Dakota James Young Bird, a minor, DOB 10/01/2007 Enrollment #: 301U-12588, has requested a Conditional Relinquishment of their son, Dakota James Young Bird’s, membership from the Three Affiliated Tribes, and has applied for membership with the Spirit Lake Sioux Tribe; and

NOW THEREFORE BE IT RESOLVED, by the Tribal Business Council of the Three Affiliated Tribes that Dakota James Young Bird, DOB 10/01/2007 Enrollment #: 301U-12588 is hereby conditionally relinquished from the official membership roll of the Three Affiliated Tribes; and

BE IT FINALLY RESOLVED that the Spirit Lake Sioux Tribe, shall be provided with a certified copy of this Resolution.

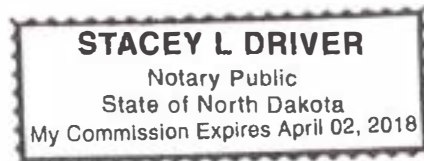


