

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution entitled, "Approval of WMSE Consulting Services – TAT Division of Child Support Enforcement "

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and
- WHEREAS, pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, pursuant to Article VI, Section 5 (1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, the Three Affiliated Tribes Division of Child Support Enforcement ("TAT DCSE") wishes to engage a consultant to provide technical assistance for establishing its policies and procedures for Child Support Enforcement; and
- WHEREAS, the TAT DSCE has utilized WMSE Consulting Services of Bloomfield, New Mexico and its owner Ellamae Williams in the past and wishes to continue to utilize said services.
- NOW, THEREFORE BE IT RESOLVED, the Tribal Business Council hereby approves the consultant contract with WSME Consulting Services to provide technical services to the TAT Division of Child Support Enforcement; and
- **BE IT FINALLY RESOLVED**, the term of the Consultant Contract with WSME Consulting shall be for a term of six (6) months beginning on April 16, 2013 to September 20, 2013 and the approved compensation of the contract shall not exceed \$15,000 for the entire contract.
