



**RESOLUTION OF THE GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled: "Rescission of Resolution #: 12-113-VJB"

- WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS,** The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS,** Article II Section 3 of the Constitution and By-Laws of the Three Affiliated Tribes grants the Tribal Business Council the power to promulgate ordinances governing future membership, the adoption of new members and the revision of the membership rolls from time to time as determined by such ordinances;
- WHEREAS,** the Tribal Business Council has authorized individuals to relinquish their membership with the Three Affiliated Tribes in order to apply for membership into other Indian Tribes and such relinquishments are authorized by resolution and are made conditioned upon said member being accepted into another Indian Tribe; and
- WHEREAS,** Tribal Business Council Resolution #: 12-113-VJB authorized the conditional relinquishment of Brandie Dawn Ree Molina Enrollment #: 301U-07574 from the Three Affiliated Tribes in order to apply for membership into the Pala Band of Mission Indians; and
- WHEREAS,** Brandie Dawn Ree Molina Enrollment #: 301U-07574 applied for Enrollment with the Pala Band of Mission Indians and was denied membership due to the receipt of per capita payments as a member of the Three Affiliated Tribes; and
- WHEREAS,** Since said relinquishment from the Three Affiliated Tribes was conditional, the Tribal Business Council finds that resolution number 12-113-VJB should be rescinded and;



NOW THEREFORE BE IT RESOLVED, the Tribal Business Council of the Three Affiliated Tribes hereby rescinds Resolution # 12-113-VJB in its entirety; and

BE IT FINALLY RESOLVED that Brandie Dawn Ree Molina Enrollment #: 301U-07574 shall have full membership in the Three Affiliated Tribes.


