



**RESOLUTION OF THE GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled: "Approval of Corporate Credit Card for the Elbowoods Memorial Healthcare Center from First National Bank and Trust of Williston, ND"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and

WHEREAS, pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, pursuant to Article VI, Section 5 (l) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and

WHEREAS, Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes Specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and

WHEREAS, The Three Affiliated Tribes has contracted health care services on the Fort Berthold Reservation under PL 93-638 from the Indian Health Service which operates as the Elbowoods Memorial Health Care Center (EMHC)

WHEREAS, The EMHC has requested permission to obtain a credit card through First International Bank and Trust for use while traveling outside of the Reservation and for other organizational purposes, and the Tribal Business Council agrees with this request; and



NOW, THEREFORE BE IT RESOLVED, that the Tribal Business Council hereby authorizes the Elbowoods Memorial Healthcare Center to obtain a credit card with the credit limit of three Thousand Dollars(\$3000) from First International Bank and Trust of Williston, ND; and

BE IT FURTHER RESOLVED, that such cards shall be in the name of the Three Affiliated Elbowoods Memorial Healthcare Center and not in the name of any individual employee ; and

BE IT FURTHER RESOLVED, that said credit card shall be used for organizational purposes of the EMHC; and

BE IT FURTHER RESOLVED, that the ECMHC shall develop a written policy governing the use and misuse of said credit cards; and

BE IT FURTHER RESOLVED, that said credit cards shall not be used at anytime for personal use and any such unauthorized uses will result in automatic payroll deductions and other appropriate disciplinary action; and

BE IT FURTHER RESOLVED, that the Chief executive officer of EMHC shall be responsible for the management of said credit cards.



CERTIFICATION
