

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "2013 Delegates to the National Congress of American Indians"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribe generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article IVI, Section 5 (1) of the Constitution of the Three Affiliated Tries provides that the Tribal Business Council has the power to adopt resolutions regulation the procedure of the Tribal Business Council and other Tribal agencies; and
- WHEREAS, The National Congress of American Indians (NCAI) is a non-profit organization whose primary purpose is to protect and preserve and promote the interest of Indian tribes and tribal communities; and
- WHEREAS, Three Tribal Business Council has deemed it in the best interests of the Three Affiliated Tribes of the Mandan, Hidatsa and Arikara Nation of the Fort Berthold Reservation to participate in those local, state, regional and national boards, commissions and other such organizations that oversee services that are now or may be beneficial to the Tribal membership; and
- WHEREAS, The Three Affiliated Tribes has been a member of National Congress of the American Indians and has paid dues for said membership;
- WHEREAS, The Tribal Business Council desires to continue participation in the National Congress of American Indians; and is required by the by-laws of NCAI to adopt the annual resolution to establish its delegates to the organization; and
- WHEREAS, The Tribal Business Council has determined that Chairman Tex "Red Tipped Arrow" Hall shall serve as the delegate to the NCAI and that Councilman <u>Randy Phelan</u> shall serve as the first alternate and Councilman <u>Ken Hall</u> as the second alternate for the Three Affiliated Tribes of the Fort Berthold Indian Reservation; and



NOW THEREFORE BE IT RESOLVED, by the Tribal Business Council of the Three Affiliated Tribes hereby appoints the following Tribal Council members to serve as delegates to the National Congress of American Indians of 2013:

- 1. Tribal Chairman Tex "Red Tipped Arrow" Hall Delegate
- Councilman <u>Randy Phelan</u> Alternate 1
 Councilman <u>Ken Hall</u> Alternate 2

IT FURTHER RESOLVED that the above appointed delegates are vested with all authority, duty, and responsibility of a NCAI delegate during tenure of their appointments.

BE IT FINALLY RESOLVED, that the Tribal Business Council hereby authorizes payment of annual dues to NCA according to Article III of the by-laws of NCAI.
