

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Authorization to Appropriate Funds from FY2015 Budget and FY2016 Budget to Self-Finance the MHA Nation Clean Fuels Refinery."

- WHEREAS, The Mandan, Hidatsa and Arikara Nation ("Nation") having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, Article III, Section 1 of the Constitution of the Nation provides that the Tribal Business Council is the governing body of the Nation; and
- WHEREAS, The Constitution generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation is empowered by Article VI, Sections 1(c) and 1(f) of the Constitution and By-Laws of the Tribe to regulate the economic affairs of the Tribe; and
- WHEREAS, The Nation has dedicated several years to the development of the MHA Nation Clean Fuels Refinery Project ("Project") near Makoti, North Dakota on triballyowned lands within the exterior boundaries of the Fort Berthold Reservation; and
- WHEREAS, The Nation has commenced construction on the Project; and
- WHEREAS, The Nation has determined that additional financing for the Project is needed; and
- WHEREAS, The Nation has received substantial revenues from its oil and gas development in the Bakken and the Nation wants to maintain 100% ownership over the Project; and
- WHEREAS, The Tribal Business Council has determined that it is in the best interests of the Nation to self-finance the Project; and

NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council hereby accepts and approves the appropriation of two hundred million dollars from the Nation's Budget in two separate tranches to self-finance the Project with the first tranche appropriated in the amount of one hundred million dollars from the Nation's FY2015 Budget and the second tranche appropriated in the amount of one hundred million dollars from the Nation's FY2016 Budget; and

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized and approved to take any and all actions necessary to carry out the terms and intent of this resolution and to enter into and sign all agreements necessary to carry out the terms and intent of this resolution.
