



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

**A Resolution Entitled: “Approval of the Purchase of Nicole Henry property located in Parshall, ND.”**

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

**WHEREAS,** The Constitution of the Three Affiliated Tribe generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** The Tribal Business Council has negotiated to purchase the “Nicole Henry” property described as:

**Legal Description: Lot 8, Block 10, Original Townsite, City of Parshall, Mountrail County, ND**

**Address: 118 Central Ave. W., Parshall, ND**

**WHEREAS,** The total purchase price of the property is \$240,000.00; and

**WHEREAS,** Upon approval by the Tribal Business Council, the Tribe will execute a purchase agreement with 10% of purchase price paid to seller as earnest money upon signing purchase agreement; and

**WHEREAS,** That Minot Guaranty and Escrow Company, located at 1829 south suite 1, Minot, ND shall complete the closing of said property for clear and marketable title; and

**NOW THEREFORE BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes hereby formally approves purchase of the property described above in the amount of \$240,000.00 for the MHA Nation.
