

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Approving contract with Revolution Advisors to develop a Reservation Management System (RIMS) for the Fort Berthold Reservation."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes was adopted By the membership of the Tribes on May 15, 1936 pursuant to the Indian Reorganization Act of 1934 and duly approved by the Secretary of Interior, and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that The Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Pursuant to the inherent sovereignty of the MHA Nation, the MHA Nation possesses the sovereign authority to establish practices on Tribal lands; and
- WHEREAS, The Grant from the Bush Foundation for the MHA Nation Tomorrow Project includes funding to develop a Reservation Information Management System (RIMS) for the Three Affiliated Tribes: and
- WHEREAS, The Revolution Advisors of 10170 Church Ranch Way, Suite 100 Westminster, CO, 80021, have the experience and capacity to develop the RIMS Program; and
- **NOW THEREFORE BE IT RESOLVED,** That the Tribal Business Council accepts the proposal from Revolution Advisors to develop a RIMS for the Fort Berthold Reservation for a fee of \$17,000.
