

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Authorization for the Edward Byrne Memorial Justice Assistance Grant (JAG) Program FY 2011"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and
- WHEREAS, pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the tribes and of the enrolled members thereof; and
- WHEREAS, pursuant to Article VI, Section 5 (l) of said Constitution, the Tribal Business
 Council has the power to adopt resolutions regulating the procedures of the Tribal
 Business Council and other Tribal agencies and Tribal officials on the
 Reservation; and
- WHEREAS, Article VI, Section 5 (d) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to negotiate with Federal, State and local governments on behalf of the Tribe and to advise and consult with representatives of the interior Department on all activities that may affect the Fort Berthold Reservation; and
- WHEREAS, The U.S. Department of Justice (DOJ) has announced and is seeking applications for funding to improve public safety and victim services in Tribal communities; and
- **WHEREAS,** This solicitation furthers the Departments and Tribes mission by providing an opportunity to develop a comprehensive and coordinated approach to apply for funding; and
- **WHEREAS,** The Tribal Business Council finds that the Tribe has an opportunity to develop an approach to apply for funding to reduce and prevent crime and victimization on the Fort Berthold Reservation, and
- **WHEREAS,** The Tribe is eligible to apply for such funds and it is in the best interests of the Tribe to apply for these funds; and



NOW THERE FOR IT BE RESOLVED, the Tribal Business Council of Three Affiliated Tribes hereby authorizes and directs and supports the Planning and Grants Department to apply for said funds under the Edward Byrne Memorial Justice Assistance Grant (JAG) Program FY 2011 Solicitation
