

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled, "Authorization for a waiver of MHA Nation Department of Transportation registration fees for any company contributing \$1,000,000.00 or more to the Adopt A Road Program for that year on the Fort Berthold Indian Reservation"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to administer any funds or property within the exclusive control of Tribes and to make expenditures from available tribal funds for public purposes of the Tribes; and
- WHEREAS, The Three Affiliated Tribes Department of Transportation would like to improve the road ways on the Fort Berthold Indian Reservation; and
- WHEREAS, The Adopt A Road program is a great program that improves our roadways on the Fort Berthold Indian Reservation.
- THEREFORE BE IT RESOLVED, The Tribal Business Council of the Three Affiliated Tribes hereby formally approves a waiver of MHA Nation DOT registration fees for that year for companies which contribute a minimum donation of \$1,000,000 to the Adopt A Road program on the Fort Berthold Indian Reservation; and
- **BE IT FINALLY RESOLVED**, The companies are still required to obtain vehicle registration through the MHA Nation DOT, but would be exempt from the registration fees for that year; and
