

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Approval of the Conditional Relinquishment of Morgen Starr Kuuipolani Dominique White Enrollment #: 301U-08706 from Membership in the Three Affiliated Tribes"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and
- WHEREAS, Morgen Starr Kuuipolani Dominique White, an adult member DOB: 02/06/1979, Enrollment #: 301U-08706 requested to be Conditionally Relinquished from the Three Affiliated Tribes to the Assiniboine and Sioux Tribes of Fort Peck; and

NOW THEREFORE BE IT RESOLVED, by the Tribal Business Council of the Three Affiliated Tribes that Morgen Starr Kuuipolani Dominique White, an adult member DOB: 02/06/1979, Enrollment #: 301U-08706 is hereby Conditionally Relinquished from the official membership roll of the Three Affiliated Tribes; and

**NOW THEREFORE BE IT RESOLVED**, that Morgen Starr Kuuipolani Dominique White, an adult member DOB: 02/06/1979, Enrollment #: 301U-08706 only be taken off the official membership roll of the Three Affiliated Tribes on the date that the Assiniboine and Sioux Tribes of Fort Peck accepts her into membership; and

**BE IT FINALLY RESOLVED** that the Assiniboine and Sioux Tribes of Fort Peck shall be provided with a certified copy of this Resolution.
