



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

**A Resolution Entitled: “Approval of the Fiscal Year 2015 General Fund Operating Budget for the Three Affiliated Tribes”.**

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

**WHEREAS,** The Constitution of the Three Affiliated Tribe generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies; and

**WHEREAS,** Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to administer any funds or property within the exclusive control of Tribes and to make expenditures from available tribal funds for public purposes of the Tribes; and

**WHEREAS,** The Tribal Business Council has the authority and is required by law to adopt an Annual General Fund Operating Budget each Fiscal Year in order to appropriate and expend its federal and general funds; and

**WHEREAS,** The Tribe operates on a Fiscal Year which began for 2015 on October 1<sup>st</sup> 2014 and ends September 30<sup>th</sup>, 2015; and

**WHEREAS,** The Tribal Business Council has authority and is required by law to adopt an Annual General Fund operating Budget each fiscal year in order to appropriate and expend its federal and general funds; and

**WHEREAS,** A FY- 2015 General Operating budget in the amount of \$86,794,000 has been formulated, and the Tribal Business Council has reviewed and hereby approves said budget; and



**WHEREAS,** A FY- 2015 Special Projects budget in the amount of \$139,656,000 has been formulated and the Tribal Business Council has reviewed and hereby approves said budget;

**WHEREAS,** A FY- 2015 Investments budget in the amount of \$125,000,000 has been formulated and the Tribal Business Council has reviewed and hereby approves said budget;

**WHEREAS,** A FY- 2015 Segments Operating and Development budget in the amount of \$72,000,000 has been formulated and the Tribal Business Council has reviewed and hereby approves said budget;

**WHEREAS,** A FY- 2015 Disbursements budget in the amount of \$29,000,000 has been formulated and the Tribal Business Council has reviewed and hereby approves said budget;

**WHEREAS,** The Tribal Business Council concurs with the Treasurer that deficit spending during fiscal year 2015 should be strictly prohibited and that internal controls will be used to ensure deficit spending does not occur and approved budgets are not exceeded.

**NOW THEREFORE BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes hereby approves and adopts the following budgets;

FY 2015 General Operating in the amount of \$86,794,000

FY 2015 Special Projects Budget in the amount of \$139,656,000

FY2015 Investments Budget in the amount of \$125,000,000

FY2015 Segment Operating and Development Budget in the amount \$72,000,000

FY2015 General Disbursements Budget in the amount of \$29,000,000; and





**BE IT FURTHER RESOLVED,**

1. That internal controls shall be strictly enforced to ensure that deficit spending does not occur in 2015; and
2. TAT Finance contracts and property shall notify the budget administrators when they have reached 90 % of their 2015 fiscal year budget allocation; and
3. TAT finance Contracts and property shall not process any documentation and/or purchase orders for programs in the General Fund Programs or Special Projects that have exceeded their budget and shall require program modifications (consistent with the approved budgets for the individual line item budget change)

**BE IT FINALLY RESOLVED.** That the budgets established and approved by this resolution shall not be modified or amended without formal resolution of the Tribal Business Council

### CERTIFICATION


