

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Approval of the Conditional Relinquishment of Tashina Leann Richardson 301U-09208 from Membership in the Three Affiliated Tribes"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and
- WHEREAS, Tashina Leann Richardson, an adult member DOB: 07/27/1986, Enrollment #: 301U-09208 requested to be Conditionally Relinquished from the Three Affiliated Tribes to Crow Tribe of Montana; and

**NOW THEREFORE BE IT RESOLVED,** by the Tribal Business Council of the Three Affiliated Tribes that Tashina Leann Richardson, an adult member DOB: 07/27/1986, Enrollment #: 301U-09208 is hereby Conditionally Relinquished from the official membership roll of the Three Affiliated Tribes; and

**NOW THEREFORE BE IT RESOLVED**, that Tashina Leann Richardson, an adult member DOB: 07/27/1986, Enrollment #: 301U-09208 only be taken off the official membership roll of the Three Affiliated Tribes on the date that Crow Tribe of Montana accepts her into membership; and

**BE IT FINALLY RESOLVED** that the Crow Tribe of Montana shall be provided with a certified copy of this Resolution.
