

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Consent to Grant an Easement on Certain Tribal land for the City of New Town Temporary Construction and a Road Easement"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and
- WHEREAS, The applications for Consents to Survey described herein have been reviewed and recommended for approval in accordance with the MHA Nation's approved procedure for authorizing Consents to survey on tribal land; and
- **WHEREAS**, The Tribal Business Council finds it appropriate to authorize the Consents to Survey described herein.
- **NOW THEREFORE BE IT RESOLVED,** the Business Council hereby grants easement for the following tribal lands:
 - 1. The City of New Town is requesting the following temporary construction easement across Tribal Lands: A parcel of land over and across Outlot 10, Section 17, T. 152 N., R. 92 W. Mountrail Count, North Dakota, which is more particularly described as follows: Commencing at the Northeast corner of Section 17, T. 152 N., R. 92 W. Mountrail Count, North Dakota; Thence S 01°25′52.9" W, along the east boundary of Section 17, a distance of 1181.13 feet; thence N 88° 34′07.1 W, a distance of 33.00 feet to the point of beginning; Thence continuing N 88° 34′07.1" W, a distance of 20.00 feet; Thence N 01°25′52.9" E, a distance 184.66 feet to the north boundary of said Outlot 10; Thence S 88° 24′58.1" E, along the north boundary of Outlot 10, a distance of 20.00 feet; Thence S 01°25′52.9" W, a distance of 184.61 feet to the point of




